- 2. The polling places for said special town election are hereby designated, and the voting districts shall be consolidated so as to allow the use of one (1) voting machine at any polling place so established for more than one voting district, as set forth in Schedule A attached hereto and made a part hereof.
- 3. The Town Clerk shall give notice of such election by publication thereof in the Dunkirk Observer and Angola Pennysaver, such publication to be at least ten (10) days prior to the date of such special town election, and by posting a copy of such notice on the sign board of the town at least ten (10) days prior to the date of such special town election.
- 4. The notice of such special town election shall be in substantially the same form set forth in Exhibit 1 attached hereto and made a part hereof.
- 5. The Town Clerk shall contact the Erie County Board of Elections to make necessary arrangements for the purposes of bipartisan selection designation of qualified election inspectors, provision of a sufficient quantity of voting machines or ballots, preparation of the necessary oaths and certificates of election, and delivery to such election officers of any and all necessary paraphernalia for the proper conduct of such election, and the Town Clerk shall keep a log of all electors requesting a ballot by mail, and shall mail a ballot to such elector with instructions for completion and mailing of same
- 6. This resolution shall take effect immediately.
- 7. A certified copy of this resolution shall be immediately filed with the Erie County Board of Elections.

- are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19);
- were not accounted for in the budget most recently approved as of March 27, 2020, for the local government entity; and
- were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020; and

WHEREAS, the County desires to distribute a portion of its allocation of Coronavirus Relief Funds with the Local Government in order to effectuate the purpose and intent of the CARES Act and to assist the Local Government in mitigating the impacts of the COVID-19 emergency; and

WHEREAS, the Town of Evans ("Town") and the County desire to enter into an intermunicipal agreement in order to set forth the terms and conditions pertaining to such distribution.

NOW, THEREFORE BE IT RESOLVED, that the Town shall enter into the attached Intermunicipal Agreement with the County governing the terms and conditions for distribution to the Town of a portion of the County's allocation of Coronavirus Relief Funds, and
