INVITATION TO BID

The Town of Evans invites bids for the **Town of Evans Pool Handicap Accessibility Project - Phase 1**. The project generally consists of **updating restrooms, adding an accessible ramp and a new water service**. Separate sealed bids labeled "BID ENCLOSED: Town of Evans Pool Handicap Accessibility Project - Phase 1" will be received by the Office of the Town Clerk of the Town of Evans, 8787 Erie Road, Angola, NY 14006, during regular business hours (Monday, Tuesday, Thursday and Friday from 8:00 a.m. through 4:00 p.m. and Wednesday from 9:00 a.m. through 5:00 p.m.) until **2:00 PM** (Local Time) on **Thursday, September 28, 2017** at which time the bids will be publicly opened and read aloud. Bids submitted by fax or email will not be accepted.

The Contract Documents can be obtained on **Monday, September 11, 2017** at the office of Clark Patterson Lee, 26 Mississippi Street, Suite 300, Buffalo NY 14203 and copies will be furnished upon receipt of \$25.00 (refundable, if returned in good condition) per set in the form of a **\$25.00** check, made payable to the **Town of Evans**. If the documents are to be mailed, a second check in the amount of **\$25.00** made payable to Clark Patterson Lee, will also be provided. Alternatively, for shipment of Bidding Documents, Bidders can provide their UPS or FedEx shipping account number in lieu of the \$25.00 check for mailing and handling. The shipping fee is non-refundable.

Each bid must be accompanied by a certified check or bid bond from a domestic carrier licensed to do business in the State of New York in the amount of not less than five (5%) of the amount of the bid submitted.

This project is funded in part by a grant from the NYS Office of Parks, Recreation and Historic Preservation through Title 9 of the Environmental Protection Act of 1993.

Bidders on this work will be required to comply with the President's Executive Order Nos. 11,246 and 11,375 which prohibit discrimination in employment regarding race, creed, color, sex, or national origin.

The successful bidder must be an equal opportunity employer, must meet all appropriate State and Federal standards, and comply with all relevant governmental regulations.

This contract will be funded wholly or partially with federal funds, and as such, is subject to all federal rules and regulations pertinent thereto, including, but limited to, federal policy of encouraging the participation of minority and women business enterprises as sources of suppliers, equipment, construction services.

Funding for this project comes in part through an **Environmental Protection Fund** grant administered by the New York State Office of Parks, Recreation and Historic Preservation (OPRHP). Under Article 15A, Executive Law, the State of New York is committed to providing **Minority and Women Owned Business (MWBE)** equal opportunity to participate in government contracts. The following goals have been set for this project: 13% Minority Business Enterprise (MBE) and 17% Women-owned Business Enterprise (WBE). The successful bidder may be required to furnish reports showing the participation of various business enterprises of subcontractors and suppliers on the contract.

A Statement of Non-Collusion and Performance and Payment Bonds will be required for this project. The Town of Evans is exempt from the payment of sales and compensation use taxes of the State of New York and of cities and counties on all materials, equipment, and supplies sold to the Town of Evans pursuant to this contract. The sales tax exemption is extended to the Contractor, Subcontractors, and their suppliers.

All bids shall be binding for a period of forty-five (45) days after the bid opening date. The Town of Evans reserves the right to reject any and all bids and to waive any informalities therein.
