The Town of Evans invites bids for the demolition and controlled demolition, with and without asbestos abatement, of structures on the following residential properties located within the Town of Evans, New York:

The project generally consists of **demolition for the complete removal and disposal of the unsafe structure(s) and foundation on each property, including work to render the properties safe, including but not limited to fill, grading, and seeding.** Sealed bids labeled "BID ENCLOSED: DEMOLITION OF 12 PROPERTIES will be received by the Office of the Town Clerk of the Town of Evans, 8787 Erie Road, Angola, NY 14006, during regular business hours (Monday, Tuesday, Thursday and Friday from 8:00 a.m. through 4:00 p.m. and Wednesday from 9:00 a.m. through 5:00 p.m.) until **11:00 AM** (Local Time) on **Friday, December 1, 2017** at which time the bids will be publicly opened and read aloud. Bids submitted by fax or email will not be accepted.

A copy of the bidding documents may be obtained from or examined at the Office of the Town Clerk of the Town of Evans, 8787 Erie Road, Angola, NY 14006 after November 17, 2017.

Questions regarding this project are to be emailed to Vincent Gugliuzza at vgugliuzza@townofevans.org no later than November 22, 2017 to allow time for responses prior to the receipt of bids.

Each bid must be accompanied by a certified check or bid bond from a domestic carrier licensed to do business in the State of New York in the amount of not less than five (5%) of the amount of the bid submitted.

Bidders on this work will be required to comply with the President's Executive Order Nos. 11,246 and 11,375 which prohibit discrimination in employment regarding race, creed, color, sex, or national origin.

The successful bidder must be an equal opportunity employer, must meet all appropriate State and Federal standards, and comply with all relevant governmental regulations. Attention of the bidder is called to conditions of employment to be observed and the minimum wage rates to be paid under the contract.

Funding for this project comes in part through an **Empire State Development Corporation** grant administered by the Restore New York Committee Initiative. Under New York State Executive Law Article 15-A and 5 NYCRR Part 142-1444, the State of New York is committed to providing **Minority and Women Owned Business (MWBE)** equal opportunity to participate in government contracts. In accordance with Article 15A of the Executive Law, this project includes a goal of thirty percent (30%) Minority and Women Owned Business participation. The successful bidder may be required to furnish reports showing the participation of various

business enterprises of subcontractors and suppliers on the contract.

Bidders will be required to comply with Code Rule 56 of the New York State Department of Labor as well as New York State prevailing wage and supplement requirements on this project.

A Statement of Non-Collusion and Performance and Payment Bonds will be required for this project. The Town of Evans is exempt from the payment of sales and compensation use taxes of the State of New York and of cities and counties on all materials, equipment, and supplies sold to the Town of Evans pursuant to this contract. The sales tax exemption is extended to the Contractor, Subcontractors, and their suppliers.

All bids shall be binding for a period of forty-five (45) days after the bid opening date. The Town of Evans reserves the right to reject any and all bids for any reason whatsoever and to waive any informalities in any bid.
