

NOTICE TO BIDDERS

The Town of Evans will receive separate, sealed bids for the furnishing of all labor, and tools, equipment as required for the TOWN OF EVANS – SEASONAL MOWING CONTRACT at various Town owned sites and facilities. This is a 3-year contract starting in May 2020 Through October 2022.

Bids will be received by the Town of Evans until 2:30 P.M. prevailing time, on Tuesday May 12, 2020 at the Town of Evans Town Hall – 8787 Erie Road – Angola, New York 14006, and then at that time and place will be opened and read aloud. The bids will only be received via US Mail, FedEx, UPS or via drop off at the Town of Evans Police Department Entrance between 9:00am and 2:00pm. The bid opening will only be available via GoToMeeting given the current COVID19 Pandemic.

All bids shall be addressed to the Town of Evans and shall be directed to Town Clerk Lynn Krajacic at the address listed above in a sealed envelope and be clearly marked on the outside of the mailing "BID ENCLOSED-Town of Evan Seasonal Mowing Contract – 3 Year Term. Failure to follow the above instructions could result in rejection of the bid.

Beginning at 9:00 a.m., on Friday April 24, 2020, the contract documents may be examined at the Buffalo Office of the CPL Team, Consulting Engineers, 26 Mississippi Street, Buffalo, New York 14203. Alternatively, for shipment of Bidding Documents, Bidders can provide their UPS or FedEx shipping account number in lieu of the \$25.00 check for mailing and handling.

Each bid shall be accompanied by a certified check or bid bond in the amount of five percent (5%) of the total amount of the bid (total of all 3 years of work).
