Community Garden Fees

A clean-up deposit of \$5.00 is required before the plot can be assigned. The clean-up deposit will be returned in the fall after you have removed all of your plants and cleaned your plot or may be used towards next year's rental fee.

Further, I agree to indemnify and hold forever harmless, against any loss which may be sustained in consequence of such participation or otherwise, the aforementioned TOWN and/or COMMITTEE, their officials, officers, employees, affiliates, agents, servants, boards, etc., their heirs, executors; and further, that no agreement, either verbal or written, shall in any manner affect this release.
